32nd Annual Farrar Reunion Minutes June 21, 2009

The meeting was opened at 10:11am by President Nancee Lehnhoff. Everyone was welcomed especially Guests. We would like to give a special thank you this year to everyone who participated in the clean up after the horrible ice storm, especially to Check and Marlene Bayes. A special thank you was also given to Tom and Nelda Farrar and Gary and Nancee Lehnhoff for all their hard work in cleaning the pavilion in the intense heat.

President Nancee Lehnhoff reminds everyone that the Farrar Clan Family Reunion is not responsible for accidents.

Minutes from the June 15th 2008 meeting were read by Secretary Nick Linebaugh. Barb Williams motions to accept the minutes as read Bob Farrar seconds, motion carries.

Treasures report was given by Treasurer Nicole Gooch. We have \$16,763.12 another \$402.80 received to deposit. Carol Rogers makes a motion to accept Treasurers Report, Barb Williams seconds, motion carries.

New Business

1)Discussion was brought up about investing the Farrar Clan funds in gold. Nicole Gooch stated that she had spoken with a stock broker who recommended not investing in gold right now. Joe Farrar said that we should invest the funds in gold, not stock in gold. President Nancee Lehnhoff said that we probably shouldn't invest all our money due to the fact that we need to pay to have our books printed this year. Joe Farrar said that we should only invest \$5,000 in gold. Ron Farrar brought up that gold is at a high price right now and any actions should be looked into before any decisions are made. Barb Williams made a motion to invest up to \$5,000 in gold. Kurt Stanford seconds, motion carries.

2)President Nancee Lehnhoff states that all 2009 dues need to be paid and that all donations will be accepted.

3)President Nancee Lehnhoff states that we need someone new to be the Farrar Clan Newsletter Editor and that Nick Linebaugh had volunteered. There was much discussion about the funding for the newsletter. When Kevin Hite produced it he had always paid for it himself. Nick Linebaugh stated that he would volunteer his time, but thought that the reunion should pay for the newsletter. Barb Williams makes a motion that Nick Linebaugh takes care of the newsletter as economically as possible this year and that he be reimbursed for his monies spent. Then we can vote next year to find out if this is going to work for everyone. Nicole Gooch seconds, motion passes.

President Nancee Lehnhoff brings up that she thinks the new editor should be proactive and call people to get new stories and information.

4)It was also brought up that we should thank Keven Hite for all of the hard work he has done over the years, and all of the awesome newsletters that he has produced. (Thank You Kevin)

5)President Nancee Lehnhoff brings up that our potable water is not safe to drink. There was much discussion over purchasing filters, what type of filters and what the cost would be. Nick Linebaugh makes a motion to post signs at every water faucet saying that our water is not safe to drink and that the reunion purchase bottled water and provide it in the pavilion for people to drink. Elizabeth Farrar seconds, motion passes.

Old Business

1)Randy Farrar makes a note that all of our Farrar Clan books need to be printed, always before the books had been printed privately. We have eight of one copy and ten of the other. The printing will provide us with 50 books of each copy. This will cost approximately \$2,400 and will last approximately three years.

Nick Linebaugh makes a motion to set the money aside for the printing of both books, Barb Williams seconds, motion passes.

2)Thanks were given to Randy and Debbie Farrar for all of their hard work in taking care of the Farrar Clan books.

3)Randy Farrar has produced a copy of the wording to amend our bylaws. This was read out loud by President Nancee Lehnhoff. Joe Farrar makes a motion to accept amended bylaws as read. Kurt Stanford seconds, motion passes.

4)Each year we elect a new officer. This year the position of Secretary is up for election. Barb Williams makes a motion to accept Nick Linebaugh. Elizabeth Farrar seconds, motion carries.

5)It was brought up by Joe Farrar that he would like to increase the donation to the Baker Cemetery from \$100 to \$200. Kurt Stanford makes a motion to increase the donation Bob Farrar seconds, motion passes.

Fraternal Grandfather of the Original Ten

Born: Flat Creek, Bedford Co., Tenn., 22 Feb., 1874. Married: Tommie Martha Fanning, 26 May, 1901. Born: New Market, Madison Co., Alabama, 6 July, 1880. Maternal Grandmother of the O-10. He died: 4 July, 1935. She died: 1 Feb., 1980. Both Buried: Rice Cem., New Market, Ala. They lived most of their married lives in Florence, Ala., arriving there in 1910. He was a postal employee and an itinerant minister for the Churches of Christ in that area; she was a homemaker.

This poem was published in the Florence Times, Sunday, 1 May, 1927.
